COURSE DESCRIPTION: This survey course provides an introduction to the major styles and movements of Western art history, from the sources of Impressionism to the end of the twentieth century. It will briefly reference the roots of the Impressionists and Post-Impressionists from ancient art to the movements of Neo-Classicism and Romanticism. The course provides an important frame of reference for further explorations in contemporary art issues or art history. Using studio, lectures, research, and presentations, emphasis is placed on developing an understanding of the key styles, methods and principles of artists and art processes of interest to the individual student.

Aim: To enable learners to identify works and artists from major movements beginning with impressionists to initiate their own research into history of areas of personal interest.

### LEARNING OUTCOMES:

Upon successful completion of this course the learner will be able to:

- 1. Describe attributes of, and the artists associated with, major historical movements.
- 2. Explain the cause and effect relationship between social, economic, religious and political change and the evolution of major art forms.
- 3. Research specific artists' biographies and artwork using various sources.
- 4. Demonstrate selected painting and drawing styles in pastiche form from chosen movements using all paint materials safely.
- 5. Explain personal affinities with specific artists and their work through research and presentations.
- 6. Reflect on, and write analyses of, historical issues and events as they relate to the emergence of art movements.
- 7. Assess the role of the art institutions and critics in the promotion and historical documentation of artists and their work.
